I went home immediately and it took me 4 hrs or a normally 1 hr trip. I did not see any sever damage in town, although there were some bricks and tiles dropped down from building.

The town that I am living is 15km closer to the quake ceter than CD and therefore should have experienced a more sever shock. When I am at home, I can tell my dog is scared. Things dropped down from rack, furniture moved, loosen paint dropped down every where.

I just dashed out again to the open area because of an after shock. Quite mild. I heard that there are quite a lot of casualty. I will take of myself, don't worry.

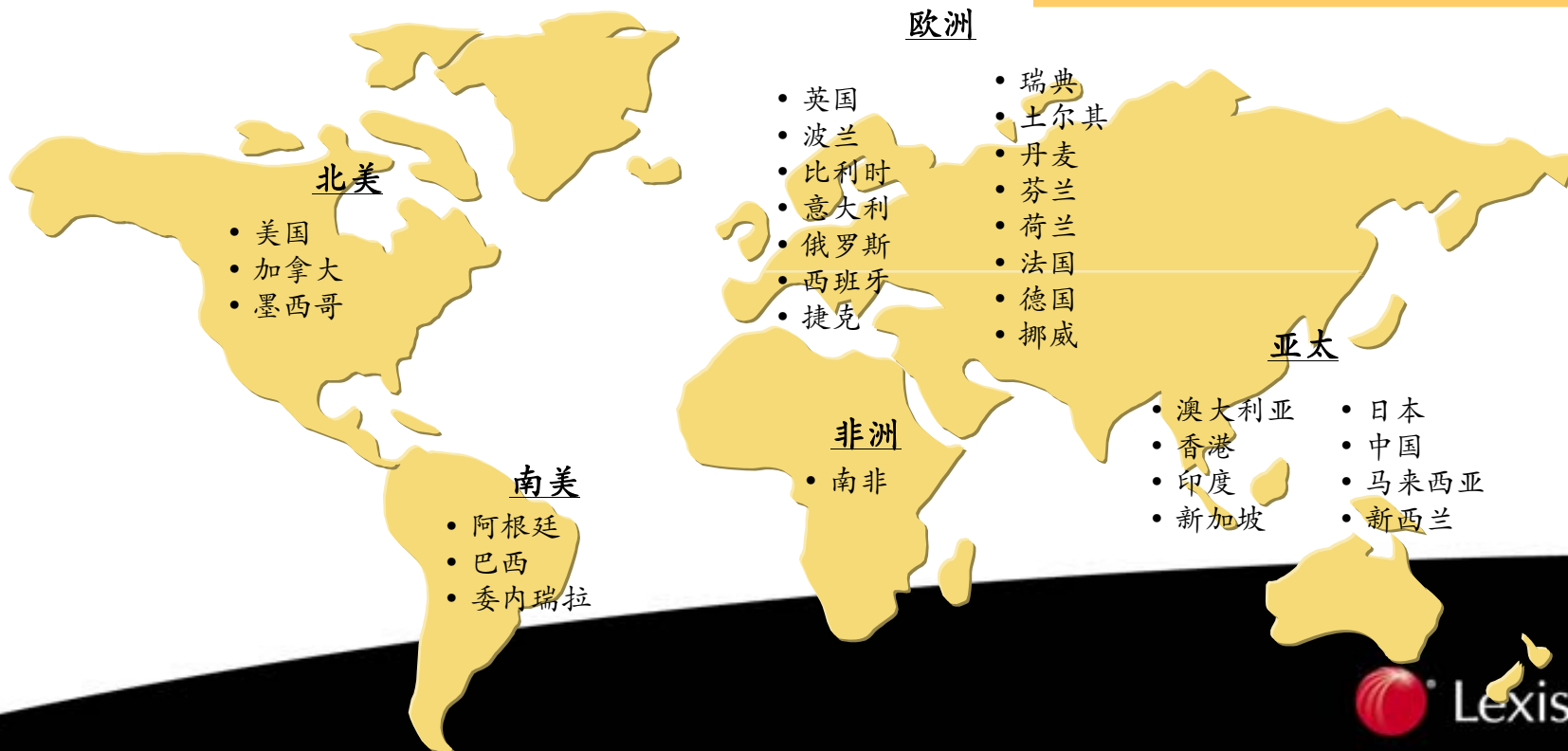

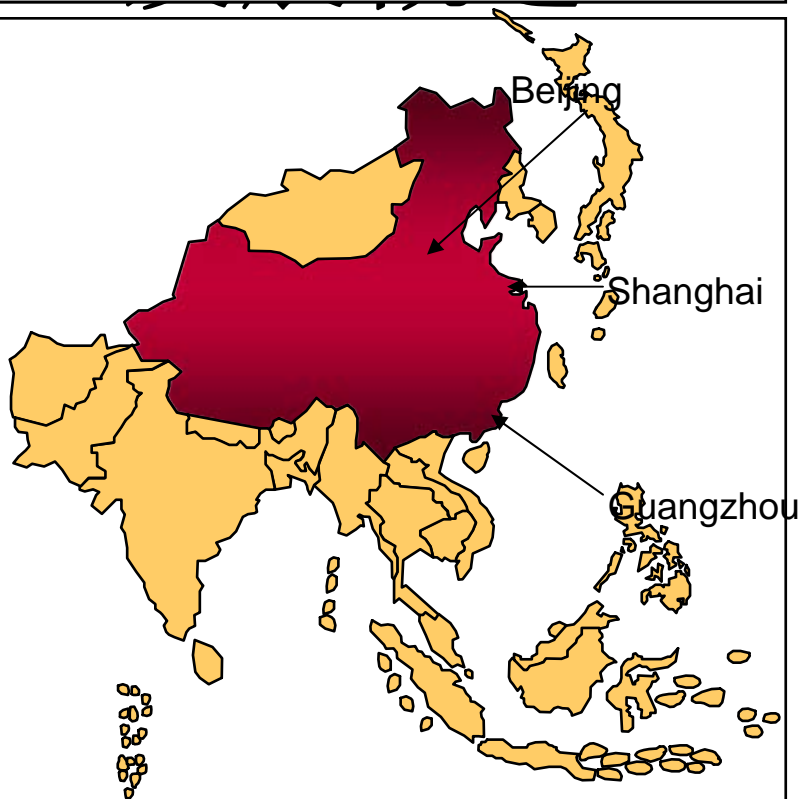
